1. **Approval of Agenda:** Mr. Loesch requested adding Meeting Chat as item "a." under New Business. The agenda as amended was approved unanimously.

a. **Meeting chat:** The Committee members discussed the pros and cons of the meeting chat. Mr. Loesch made a motion to discontinue the chat function in this Committee meeting and future meetings. Ms. Parrish stated that she could not turn of the chat for the current meeting, but she would be able to turn it off in future meetings. Mr. Loesch amended his motion to state that the chat

- function should be disabled in future Committee meetings. Ms. Schwartz seconded the motion. The motion passed, five for, two against.
- b. **Format for report to Village Board:** The committee discussed the format the report should take. Mr. Inglis proposed that each group send their findings to Ms. Parrish. Ms. Parrish will organize the findings based on the various topics the committee is researching.

- **a. Present research on topics to review:** The committee members presented new research on the review topics. The committee members discussed the topics, but they did not make any specific decisions about any of the topics.
