### Village Board Meeting Minutes

April 8, 2024 at 7:30 pm

**Members Present:** Kristine Amari, Jared Ball, Jeremy Domm, Steve Hannan, Bill Inglis, Chris Smith and Skye Anderson. Mariah Robertson had an excused absence.

**Staff Present:** Laura Mayton and Emily Rieger

**Guests:** Approximately 20 guests

**Call to Order:** 7:30 pm

1. **Approval of Agenda:** Mr. Inglis made a motion to approve the agenda. Mr. Hannan seconded. The motion passed unanimously.
2. **Approval of the March 11, 2024, Meeting Minutes:** Mr. Inglis made a motion to approve the March 11, 2024, meeting minutes. Mr. Domm seconded. The minutes passed unanimously.
3. **Board Update:** Mr. Domm highlighted the County Executive Office's proposed capital budget, which includes \$14.5 million for cycling and pedestrian projects. Ms. Anderson congratulated Emily Rieger, whose photo was selected as one of the Village's winners in the Columbia Association photo contest.
4. **Resident Speak-Out:** Several residents spoke in opposition to a proposed CA tree planting project on Open Space in a grassy area behind homes on Satinwood Drive.
5. **CA Board of Directors Report—Skye Anderson:** Ms. Anderson provided an update on new "play area" designs to replace tot lots, aiming to serve more age groups. Resident feedback will be part of developing policies.
6. **New Business:**
  - a. **Donation Requests: Grassroots, Atholton HS PTSA, Harpers Choice MS PTA, Clemens Crossing ES PTA, Bryant Woods ES PTA, Columbia Festival of the Arts, Wilde Lake HS PTSA, Community Ecology Institute (Freetown Farm):** The Board reviewed donation requests of the Hickory Ridge Village schools several organizations. Mr. Domm made a motion to donate \$1,000 to each of the five schools. Mr. Inglis seconded. The motion passed unanimously. Dr. Ball made the motion to increase the donation to Grassroots from \$3,000 to \$5000 and to increase CEI's donation to \$2,000. Mr. Inglis seconded. The motion was approved unanimously. The Board discussed the donation request from the Columbia Festival of the Arts but decided that they would postpone a vote and revisit their donation request at the next Board meeting.
  - b. **Other Donations:** Mr. Inglis asked the Board to reinstate a scholarship program to help local students in need. After much discussion, Ms. Amari recommended reaching out to

the staff at Wilde Lake to inquire about their partnership with Howard County Community College.

- c. **Volunteer of the Year:** Mr. Inglis made a motion to honor Alan Schwartz with a \$100 dining gift certificate and a plaque in appreciation of his efforts in the Village. Ms. Amari seconded. The Board voted one in favor, three against and two members abstained. The motion failed. Mr. Smith recommended a transparent process be created for recognizing Village volunteers, including a Volunteer of the Year award. Ms. Mayton offered to post the Volunteer of the Year nomination form through the Village's social media platforms with a deadline of submission being May 13<sup>th</sup>.

## **7. Old Business:**

- a. **Satinwood Tree Project:** After listening to residents express their opposition to the tree planting project during Resident Speak-Out, the Board discussed the proposed project. Mr. Inglis made a motion to send a letter of concern to Open Space requesting that they delay they project. Mr. Hannan seconded. The motion passed unanimously.
- b. **CA Management Contract Addendum:** Board members discussed a proposed, joint letter to Columbia Association with River Hill and Owen Brown advocating for an adjustment to the assessment share. The Board would like to do this before signing the second addendum to the management contract which extends the Village's management contract with Columbia Association through April 2025. Mr. Hannan will continue to work with representatives from Owen Brown and River Hill to edit the proposed joint letter.
- c. **Proposed Easement Policy:** The Board discussed the proposed easement policy and reviewed the draft letter written by Mr. Smith. Ms. Anderson shared that the easement policy is on the CA agenda and advised the Board to wait to send the letter. Mr. Inglis made a motion to send the letter. Mr. Smith seconded. The motion passed 3-2-0.

- 8. **Manager Report-Laura Mayton:** Ms. Mayton encouraged the Board and Village residents to attend the Hickory Ridge Community Celebration event on April 19<sup>th</sup>. She shared that the Community Engagement Committee hosted a successful happy hour on March 18<sup>th</sup> at Asian Palace with several residents in attendance.

## **9. Action Items:**

- a. Ms. Mayton will send a letter to Columbia Association staff regarding the proposed tree planting project to request delaying the project until further resident input is gathered.
- b. Ms. Mayton will publicize the Volunteer of the Year award through social media to solicit nominations from the community.

- 10. **Adjournment:** Mr. Inglis made a motion to adjourn the meeting. Mr. Smith seconded. The motion passed unanimously. The meeting adjourned at 9:55pm.

Each year, our PTA strives to support students and families by working with the school and community partners, organizing activities, and offering opportunities to all students.

We've had a successful and busy year! #### **Who will receive the service?**

Grassroots Crisis Intervention Center operates Howard County's only emergency shelter at our location at 6700 Freetown Road in Columbia. The shelter serves families and individuals experiencing homelessness. Shelter residents receive comprehensive case management services which include a room, 3 meals a day, support to develop a housing plan, assistance with transportation, help with applications to social services and behavioral health services, access to employment volunteers for job search assistance, and help with applying for housing. The program can provide shelter for up to 10 families and 24 single adults at any given time. When families and individuals move out of shelter and into stable housing, they have very little to no furniture. The most basic item that someone needs when moving into a new home is a bed. Grassroots partners with a leasing company to get like-new queen size beds for our clients for \$300. This includes the frame, box spring, and delivery. Without this arrangement, most of our clients would be sleeping on a blow-up bed or on the floor.

#### **How many people?**

Grassroots provides shelter to about 90 individuals or 40 households a year. With support from the Hickory Ridge Community Association, Grassroots would be able to provide beds for 10-15 individuals depending on the family size and ages of children.

#### **What will the donation be used for?**

The funding would be used to purchase queen size beds through Progressive Leasing or through Walmart/Amazon for twin size children's beds or toddler beds. While we have an arrangement with Progressive Leasing for like-new queen beds for \$300, beds for children or toddlers are

purchased online for less. The partnership between Grassroots and Progressive Leasing also keeps these like-new but unsellable mattresses out of the landfill by allowing them to be picked up after events like home staging and used by low-income individuals. It is a win all around. As a side note, Grassroots partners with Home of Our Own Howard (HOOOH) which provides furniture to clients moving from homelessness to housing. Home of Our Own often struggles with having beds available so Grassroots buys the beds and HOOOH provides the rest of the furniture. Home of Our Own Howard is an organization that was founded by a Hickory Ridge resident, Betty Pearson.

**What is the total budgeted amount of the project?**

About \$10,000 annually. Grassroots rehouses about 2 to 4 households a month. Grassroots is requesting \$3,000 which would allow us to purchase 10-15 beds.

**How are other funds being obtained? What other organizations have made or will be making donations?**

In the past, this project has received financial support from the Community Foundation of Howard County, The Women's Giving Circle, and PNC Bank Foundation. Those funds have been used up so we are seeking additional support so we can continue to purchase beds for clients as they move out. Grassroots will continue to solicit donations from other organizations in Howard County to support this cause. These include other Community Associations, rotaries, and organizations.

Owen Brown Community Association (OBCA), River Hill Community Association (RHCA), and Hickory Ridge Community Association (HRCA) acknowledge receipt of a letter dated 1 March 2024 from CA General Counsel Mr. Kuchno, denying our requests to renegotiate the structure and funding of our contracts with CA before signing a new agreement.

OBCA sent a letter in October intending to initiate a productive dialog with CA around several substantive issues in the assessment share formula and management contract, with ample time to resolve those issues ahead of the contract's expiration on 30 April 2024. While OBCA has been proactive in bringing these issues to CA's attention several times in recent years, and while CA has previously responded that the assessment share would be re-assessed in FY24, we understand that time is now short to reach an agreement before our contract expires. With the goal of reaching an agreement in good faith that addresses these concerns, we've attached a **modified** management contract amendment which OBCA, RHCA, and HRCA are willing to sign as a short-term solution until the assessment share and contract terms can be renegotiated in FY25. The modification addresses the primary inequity that we've brought to CA's attention in prior requests.

However, should CA and our community associates not be able to reach an agreement, we are committed to an orderly transition of community center operations from the association to CA Staff, and a good-faith negotiation toward a separate agreement covering the many aspects of our current relationship which extend well beyond management of the facility. Community center operations include:

- Provision of office space for the functions of the community association (architectural enforcement, events, community advocacy)
- Provision of pro bono event space for community activities
- Rental operations of the Community Center
- Continuity of operations with several long-term tenants
- Furnishing and maintaining the interior of the building.

If CA prefers its staff to assume these responsibilities, a transition must start right away to ensure continuity of services to the nearly 30,000 residents in our three villages.

We are eager to engage with CA to discuss the path forward for our relationship. Our respective Managers and Chairs would like to continue this discussion **(on specified date)**.

Dear Mr. Matthey, Mr. Greenberg and Mr. Stack:

We are writing to express our perspective on CA's consideration of potential updates to the easement procedures. These procedures have been in place for 16 years and we believe that there is a need to address deficiencies in how easements have been considered since 2008.

Any revisions to CA easement procedures should reflect a number of principles:

- Establishing an outside, independent review of easement appraisals that includes a detailed analysis of the costs/benefits of any easement and any financial impact on CA's budget. Such a review will be made available to the public prior to Board consideration of the easement.
- Enhanced public notification requirements when the CA Board is considering easements that includes at least 10-day notice and direct notification to impacted homeowners.
- Recognizing that the current easement procedures requiring the transaction promote the "social welfare of the people of Columbia" and a finding of the "civic betterments or social improvements" needs to specifically account for any positive or negative environmental impacts of the easement.

We hope that the CA Board's future discussion and adoption of changes in easement procedures will reflect the principles outlined above. Thank you for considering our views on the matter.
