CARES Recommendations for Excess Cash Reserves with Columbia Association

The HRV CARES group has come up with some ideas to spend the ~50K that CA is holding for our Village. Details about the project are on the following pages. In brief, they have discussed:

- 1. Add a pollinator garden in the Clary's Forest loop area,
- 2. Add landscaping stones to the side of the pathway off of Watch Chain (CA tends to drive trucks into the Open Space here),
- 3. Replant the area by the Village office that was recently weeded by Weed Warriors (must verify that this location is on CA property),
- 4. Put toward the cost of additional shrubs for townhomes for next year's tree give away, and
- 5. Cover the cost of soil tests to be used as a give-away item at a landscaping seminar.

#1 - POSSIBLE ENVIRONMENT PROJECT IN HICKORY RIDGE VILLAGE

The following documents an area of interest/concern in Hickory Ridge Village on CA Open Space where an environmental project could be considered

LOCATION

CA open space in Clary's Forest circle formed by Ltl Patuxent Pkwy. Plat 5903

DESCRIPTION OF CONCERN OR ISSUE

There is a large open space by the paths in the circle. Part of this space is mowed, other is being overrun by invasive plants ((like Japanese Stilt Grass)

INDICATE HOW CONCERN OR ISSUE IMPACTS PEOPLE/ NEIGHBORHOOD/WILDLIFE

Invasive plants are choking off native plants and destroying habitats for local wild-life

IF YOU HAVE IDEAS OR OPTIONS TO FIX THIS WHAT WOULD THEY BE

Adding a pollinator garden with native plants in this area would beautify that area and attract needed pollinators.

As an added bonus, children at the nearby playground will be able to see an increased number of butterflies.

If signage is included the pollinator garden would let residents know what the native plants are and what insects will benefit from it.

POSSIBLE CONCERN WITH SUGGESTED IDEA

CA will need to undertake maintenance of the pollinator area so mowers don't accidentally destroy it.

SUGGESTED IMPLEMENTATION BUDGET

#2 - POSSIBLE ENVIRONMENT PROJECT IN HICKORY RIDGE VILLAGE

The following documents an area of interest/concern in Hickory Ridge Village on CA Open Space where an environmental project could be considered

LOCATION

Watch Chain Way and CA Path (Plat 6845)

DESCRIPTION OF CONCERN OR ISSUE

This is a high traffic area: CA/HoCo use this part of the path to bring trucks into the open space area. After work is completed, the area is seeded. However, grass doesn't grow well here due to both trucks and water flow caused by heavy rains.

INDICATE HOW CONCERN OR ISSUE IMPACTS PEOPLE/ NEIGHBORHOOD/WILDLIFE

In addition to being unsightly, this area continues to erode causing ruts and creating unsafe areas for the community to walk.

IF YOU HAVE IDEAS OR OPTIONS TO FIX THIS WHAT WOULD THEY BE

Instead of re-seeding the area repeatedly consider the use of landscape stones that will survive the truck traffic and will reduce the safety issue.

POSSIBLE CONCERN WITH SUGGESTED IDEA

CA should consider appropriate stone and a fill layer beneath that will allow water to be absorbed during rainfall. .

Hickory Ridge Village

DESCRIPTION OF CONCERN OR ISSUE

In 2025 CA donated 100 plants and 100 trees for us to give away to our residents. We hope they will do the same again in 2026. We are asking that they increase the number of native trees for our village by 25 and add 25 native shrubs.

INDICATE HOW CONCERN OR ISSUE IMPACTS PEOPLE/ NEIGHBORHOOD/WILDLIFE

Our village residents were pleased to sign up and show up to get trees, and we actually could have used more.

IF YOU HAVE IDEAS OR OPTIONS TO FIX THIS WHAT WOULD THEY BE

In addition to more trees we would like to have some shrubs to give out for residents who live in townhouses or condominiums, since their yard sizes may not support the planting of a tree.

POSSIBLE CONCERN WITH SUGGESTED IDEA

CA may need to explain to other villages why we will have a larger volume of native trees to offer to our residents.

LOCATION

Hickory Ridge Village

DESCRIPTION OF CONCERN OR ISSUE

In past years CA offered free soil tests to residents in the hope that they would reduce the amount of fertilizers they applied to their lawns. Each test provided the resident with the details of the nutrients already in their lawn soil. Unfortunately the grant to provide the soil testing service was exhausted. .

INDICATE HOW CONCERN OR ISSUE IMPACTS PEOPLE/ NEIGHBORHOOD/WILDLIFE

Our village residents if they get such a test done are more likely to apply less fertilizer if their lawn are already rich in the nutrients needed.

IF YOU HAVE IDEAS OR OPTIONS TO FIX THIS WHAT WOULD THEY BE

The CARES team is intending to offer yard-scaping seminar in early spring and would like to again encourage our residents to reduce fertilization. We would like to offer free soil testing, on a limited basis, to our residents. CA has a better capability to procure these testing services at a low cost per unit. We would ask CA to procure 100 soil test kits through a reputable service and provide them to the village office where they can be distributed. We would also offer these tests to residents who attend the yard-scaping seminar.

POSSIBLE CONCERN WITH SUGGESTED IDEA

CA may need to explain to other villages why we will have soil testing available.

SUGGESTED IMPLEMENTATION BUDGET

Cluster Box Maintenance Procedures for Single Family Neighborhoods

When Columbia, MD, was developed, cluster box units were installed in single family detached home neighborhoods for mail delivery and since that time, the United States Postal Service (USPS) has maintained them. This pamphlet was created to help Columbia's residents understand and navigate USPS's process when seeking repairs and maintenance to damaged cluster mailbox units.

Should you require USPS maintenance, follow these steps:

- Location of the cluster box in need of repair or replacement.
 - Be sure to specifically identify the area as a single family neighborhood. Procedures differ for apartments and corporate cluster boxes.
- List the unit's 5-digit, USPS-marked, postal ID number. This is usually visible on the front or side of the body or pedestal
- Describe the issue with the cluster box and why it requires maintenance. Be sure to indicate any safety hazards.
- Contact your local Postmaster which can be found from this web address. tools.usps.com/find-location.htm
- Request the Postmaster put in a service ticket using the information gathered above.

Frequently Asked Questions (FAQs):

- Q: What if the USPS Employee says USPS does not repair or maintain cluster boxes? Residents
- A: should speak to the Postmaster directly in order to submit their request. Be sure to tell them the cluster box is located in a single family neighborhood. Cluster boxes in multifamily neighborhoods like apartments, condos, and townhouses may be privately owned.

Postal Operations Manual Chapter 6.32 and USPS Bulletins 22545 and 22571 establishes that USPS does, in fact, maintain cluster box units located in single family detached home neighborhoods and that they have specific procedures in place for repairing and replacing hazardous or damaged cluster box units.

- Q: My cluster box is an eyesore, what can I do to get it replaced?
- A: Currently, USPS has stated they do not have the funding for aesthetic repairs or replacements. Instead, they are recommending aesthetic repairs that can be addressed by residents raising the necessary funds privately.
- Q: My request has been submitted, what happens next?
- A: The Postmaster will log the request, dispatch service personnel to investigate the cluster box according to the USPS Equipment Review Procedures, and then implement repairs (or replacement) as determined by the inspection.
- Q: What if USPS referred me to the Columbia Association when I spoke with them?
- A: CA has not now, or ever, been a part of the federal mail delivery service. CA does not own cluster mailbox equipment nor is it installed on CA property. In some multi-family neighborhoods, private HOAs may maintain the equipment, however that situation does not apply to single family neighborhoods.
